Certificates of Completion older than two years may be assessed an additional charge.

Reports, Informational Building Permit Records: \$20.00

**Records, more than two years old:** \$40.00 per hour when extensive clerical

assistance is required.

**Review and Stamping of Additional Sets of Plans**: \$10 per page.

\*Construction costs will be calculated using the "Building Valuation Data" chart as published in the Building Safety Journal, a publication of the International Code Council, or the contracted price, whichever is greater.

\*\*Requests for inspections out of normal building department inspection hours must be scheduled 48 hours prior to the requested inspection time. Normal building department inspection hours are Monday through Thursday, 7:30am – 5:30pm, excluding holidays.

\*\*\*A fee of \$100 will be assessed to permits when the work is completed and the permit holder fails to schedule a final inspection within 180 days of the permit issuance date or 180 days after the last approved inspection, whichever is latest.
